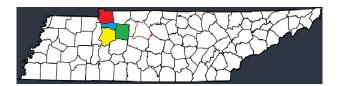
#### **FAMILY SERVICES**

#### **HEALTH SERVICES**

Head Start Health Services works in collaboration with parents in effort to provide children comprehensive health services including medical, dental, mental health, and nutritional services. Parents are encouraged and assisted to ensure their children are up to date and on schedule with the State EPSDT schedule. Follow-up treatment, dental care and psychological services are provided as needs are identified.

#### **FEDERAL REVIEW**

Highland Rim Head Start did not undergo any federal reviews in the 2016-2017 school year. The most recent reviews of the program were in the 2015-2016 school year. During that year, Highland Rim Head Start underwent CLASS Review, Comprehensive Services and School Readiness Review as well Leadership, Governance, Management Systems Review.. While there were no concerns with the CLASS review, there was one concern and one noncompliance in the CSSR three review and areas noncompliance in the LGMS review. Each area of noncompliance has been corrected.

### **FINANCIAL AUDIT**

The independent audit for the 2016-2017 school year resulted in zero findings.

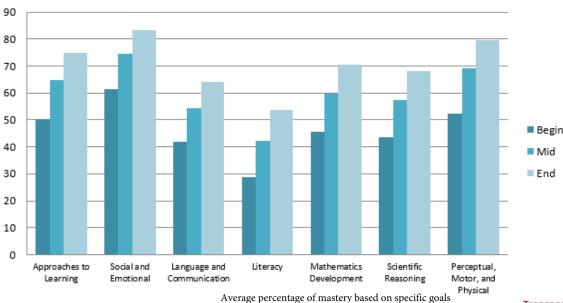


### **SCHOOL READINESS**

Highland Rim Head Start utilizes the Learning Accomplishment Profile 3 (LAP-3) to complete ongoing assessment of children enrolled in the program. The data is aggregated and analyzed to determine how children are progressing through the year.

#### Percentage of Mastery



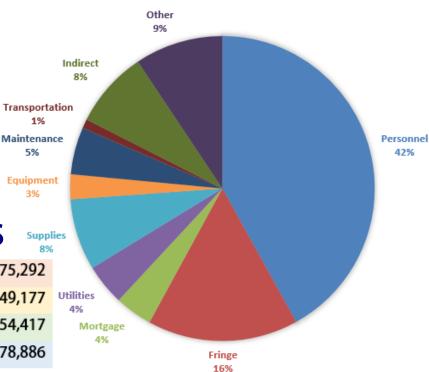
# KINDERGARTEN READY
